393.681,90 Euro 1.744.254 Euro


MUST until end of PR5 (May 2013): 1.600.000 Euro

2) Status quo indicators/outputs/results

IMPORTANT:

- Controlling tools output indicators are needed from WP Leader
- •We rely on you as we cannot know all achieved outputs/indicators
- Indicators in PPR are not sufficient
- •The indicators do not only refer to you as WP Leader but to all PPs involved in the respective WP, also the IPA PP
- •We need additional information about the outputs
- •The overvall report can only be as good as the information we get from you
- •We agreed on that in Zarnesti
- •Missing for PR4: WP2, WP7, WP6







3) Project change- status quo

CZ PP change – 20% ASP PP:

"informal" approval by JTS via Email, but no official approval yet →PA addendum still missing from UNEP

Project prolongation:

All documents submitted to JTS together with CZ PP change and decommittment

→ final "approval" together with CZ PP change approval







Change in partnership – INC PAS

ERDF 20% PP2 - INC PAS - Poland

- INC PAS cannot stay in the project any longer due to internal financial problems
- Will be replaced by UNEP/GRID Warsaw
- Written request and formal documents have to be submitted to JTS
- Preparation is currently on-going
- Support from UNEP and consortium needed







Possible contributions of UNEP/GRID Warsaw:

WP3	Will contribute to all activities foreseen to be implemented by INC PAS, i.e. input to Carpathian Red lists → discussed and agreed with Tereza – status quo?
WP4	4.1 - deliver data for study on regional development opportunities for PA and natural assets 4.2 - deliver data for CIMM →GRID Warsaw would have to sub-contract experts for that work but do not have any budget left for this, moreover no sub-contracting is possible before formal approval of PP change is given by JTS →no results until May 2013 possible →any reply to Hildegard – status quo?
WP5	GRID Warsaw is currently working on documents provided by EURAC and try to figure out what they can deliver → plan to increase WP5 budget with originally WP7 budget → any reply to EURAC – status quo?

WP7

→ Probably no contributions as the approval by JTS might be too late, moreover the sub-contracting of experts would be necessary and this procedure could only start after final approval of PP change
