#### III.1 Activities performed to achieve project outputs

The following activities have been conducted during the project:

**The preparatory meeting** for the organization of the Forum Carpaticum (FC) was held in Budapest, Hungary on October 1<sup>st</sup> and was useful to discuss organizational and substantial issues, as well as to pre-discuss follow-up activities.

The Forum Carpaticum Conference has been held, as planned, in Eger, Hungary on October 15-19<sup>th</sup>. The Conference Programme and Book of Abstracts can be downloaded from the conference website (<a href="http://fc2018.hu/">http://fc2018.hu/</a>). The Forum has been implemented as planned for the most part. The challenges included lack of participation of colleagues from Serbia, due to the short notice of the funding available, as well as some small organizational deviations, and the challenge of reporting by the Hungarian organizational company after the Forum Carparicum, due to legal unclarities. The expenditures have been lower than expected due to a lower than expected number of participants.

Two Carpathian sessions have been co-organized on November 7<sup>th</sup> and 8<sup>th</sup> during the Congress on Agritourism in Bolzano, Italy (November 7-9, 2018). During the first interactive session, followed by a framework setting presentation of the Carpathian Convention, participants from various Carpathian countries, representing different aspects of the Agritourism sector (practitioners and researchers, as well as participants involved in governance) presented information about the main challenges of agritourism development in the Carpathians. Discussion followed involving all session participants. During the second session the results of the discussion have been presented, and information about Forum Carpaticum, and specifically its aspects linked with Agritourism have been presented, followed by a scientific presentation focused on potential for agritourism development in Hungary. In addition to presentations focused on the Carpathians, case studies from other countries have been shared, which resulted in an international exchange on good examples and challenges in the field of agritourism. A summary paper based on the Carpathian sessions has been submitted to the Congress proceedings volume, under preparation by EURAC research, to be published by Springer. This is an additional deliverable, not envisioned in original outputs of the project. Moreover, the coorganizers and participants of the sessions followed up by organizing training workshops on "Digital and Marketing Ecotourism", which took place in Hungary in February 2019 and on "Social Enterprises and Community Development in Rural Areas," which took place in **Poland in May** 2019, supported by the Visegrad fund<sup>1</sup>.

**WWF** held a meeting "Gift to the Earth" on 8 November 2018 in Vienna, Austria, and presented the Carpathian Convention with the prestigious WWF "Gift to the Earth" Award<sup>2</sup>. Science for the Carpathians steering committee members from Hungary and Slovakia attended the meeting. Before the meeting an interview with Dr Lubos Halada, Deputy Director of the Institute for Landscape Ecology at the Slovak Academy of Science and a representative of Science for the Carpathians (S4C) was released by WWF, in order to discuss the state of Carpathian biodiversity, with respect to the global situation depicted in the WWF 2018 Living Planet Report. The statement pointed to the results of the Forum Carpaticum conference that recently took place on 15-18 October 2018 in Eger in Hungary, and can be found following this

link in the footnote<sup>3</sup>. This is an additional event, contributing to the project outcomes, but not envisioned in the original project application.

A meeting of the Carpathian Convention Implementation Committee (CCIC) was held in Vienna on 17 - 19 December 2018. Main recommendations from the FC have been presented by the 2 representatives of the S4C, and discussed there. The results of the Carpathian Sessions held during the Agritourism Congress have also been presented and discussed. Both of these are reflected in the Progress Report of the Carpthian Convention, finalized at the meeting, and mentioning also the support by the AAP programme. The details of the CCIC meeting and all documents can be found at the website of the Carpathian Convention<sup>4</sup>:

- At the CCIC it has been decided that stronger collaboration between the S4C and the Carpathian Convention is welcome, and could take place of S4C members presenting at Carpathian Convention meetings and contributing to the decision-making.
- Moreover, Hungary offered to organize a seminar in 2019 on the issues on environmental and sustainable development education and awareness with the aim of exchanging best practices in the Carpathian region and exploring of further cooperation. Participants considered the outcomes of the workshop on Education for Science and Society in the Carpathians, which was organized with support of the Secretariat at the Forum Carpaticum 2018, specifically the opportunity to broaden up the seminar as an opening for better recognition of the education, especially ESD, in the Carpathian Convention's agenda.

\*The CCIC meeting and the resulting interaction is an important outcome of the project and provides evidence of the important contribution the project made to strengthening the science – policy – practice interface in the Carpathian region. This event was not a specific part of the project application – however, it is an additional outcome and the resulting events point to the dynamic nature and the sustainability of the Carpathian Convention activities.

Subsequent to the offer of Hungary to hold the ESD Seminar, the Hungarian Ministry of Human Capacities has requested the Secretariat to support the organization and participation of a number of Carpathian participants in the Seminar. Due to the fact that some funds were left over from the Forum Carpaticum, a request for project amendment has been submitted and approved.

The follow-up S4C meeting has been organized and held on April 15-16, 2019 in Budapest, Hungary. The meeting had an aim to discuss lessons learned from the organization of FC 2018 and the stronger integration of S4C and CC, as well as planning of FC 2020 and the potential of applying for the Visegrad funds. Moreover, follow-up on the reporting of Forum Carpaticum took place.

- Participants decided on the preliminary dates, venue, and programme outline of the FC 2020, to be organized in Brno, Czech Republic, on June 23-26, 2020.
- It has been decided to apply to the Visegrad Fund for the forum. The projet would include a preparatory meeting, a follow-up meeting, a FC summer school and participation in Carpathian Convention activities by S4C representatives.
- It has been agreed that closer collaboration with the Convention Working Groups should take place, and the S4C in cooperation with the CC should explore a potential new format for more collaborative interaction.

\*The importance of this follow-up meeting was that Science for the Carpathians network has not had a chance before the support by AAP to meet together physically and dicuss cooperation and joint events. The face-to-face meeting provided an opportunity to follow-up on many ideas and to make important decisions about the next joint steps, such as developing an application for the Visegrad funds, planning the Forum (with strong participation of the local community), and other events, such as the summer school for young researchers.

The ESD Seminar has been organized and held on April 16-18, 2019 in Budapest, Hungary. The Carpathian Convention Seminar on Education of Sustainable Development took place on 16 – 18 April 2019 in Budapest, Hungary. The seminar was organised by the Ministry of Human Capacities of Hungary in strong collaboration with the Ministry of Agriculture of Hungary and the Secretariat of the Carpathian Convention. Professionals from all Carpathian Countries (Czech Republic, Hungary, Poland, Romania, Serbia, Slovak Republic and Ukraine), including teachers, teacher educators, researchers and ministry officials as well as international experts came together to exchange experience and discuss the challenges of implementing ESD in their respective countries and on the regional level. The seminar's mission was to establish a new and enduring tradition of transdisciplinary networking and cross-country exchange in ESD. One of the workshops, organized by the S4C in cooperation with the Secretariat, focused on identifying main barriers, most suitable competences and how S4C/research can support ESD in the Carpathians. At the end of the meetings participants discussed policy follow-up and have recommended to establish a WG on ESD of the Carpathian Convention, and develop a protocol.

The meeting of the Working Group on Biodiversity was held in Ostrava, Czech Republic, on May 30-31, 2019. The meeting was preceded by a multi-sectoral workshop on minimising the impact on birds from powerlines, held on the 29.05.2019, in which representatives of scientific institutions, the industry, and the focal points of the Carpathian Convention took part. The meeting was concluded by a workshop on cooperation of the S4C with the Biodiversity WG held on May 31, 2019. The workshop with S4C was initiated by 2 presentations (first by the Polish scientists, second - joint presentation of the S4C participants), and then continued in intense discussion rounds, in which specific questions and formats of cooperation between the S4C and the working group members, as well as focal points of the Carpathian Convention was discussed. This format was much appreciated by the Secretariat, the focal points and the scientists. WWF colleagues and other S4C members who could not attend provided inputs before the workshop, which have been integrated into the diccussion.

\*Another unplanned outcome of the project is that the transdisciplinary, multi-sectoral synergies and strengthened science-policy-practice interface will be reflected in the research agenda for the Carpathians, to be redeveloped in a participatory manner by the S4C for 2020-2030.

The meeting was followed by a S4C working session in the afternoon of May 31st, in which the application to the Visegrad Fund to organize the Forum Carpaticum 2020 and additional activities to strengthen science-practice-policy interface and inter- and transdisciplinary research in the Carpathians has been further developed by the S4C participants. It has been decided, due to the short timing before submission, to develop the application further and submit it on October 1st, 2019.

All of the above activities were condusive to achieving the planned project outputs. Some of the activities described above have not been envisioned in the original project application (CCIC, ESD Seminar and participation of the S4C in the WG on Biodiversity), but have emerged during the project implementation, and reflected in the amendment request. The project has been extended based on saved funds and in order to integrate the additional activities, as well as to allow for a better prepared and elaborated follow-up. In this respect, the follow-up meeting of the S4C has taken place later than expected in the original application, which allowed more indepth reflection on the results of the FC and facilitated preparation of the transdisciplinary exchange during the Working Group on Biodiversity meeting, described above.

Support the participation of students, PhD student and early career young scientists in the FC

A number of younger participants (8) have been supported, as planned – even more came with support from their institutions

The total Number of participants in Forum Carpaticum have been estimated between 110 and 160 in the original application (110 registered paticipants taking part in the sessions and workshops, and 160 attending the gala dinner, including potentially local stakeholders /administration and nonregistered organizers)

The actual number of participants was estimated at 120: 108 were registered (coming from at least 15 different countries), and the additional 12 were Hungarian organizers and supporters of the conference, who were not registered.

Supporting participation of the S4C and Carpathian Convention in the Carpathian session during the Agritourism Congress in Bolzano, Italy.

9 presenters from the Carpathians have been supported at the Agritourism Congress, including a representative of the S4C, nominated by the S4C steering committee, who is also a young scientist/researcher working in the field of agritourism and women empowerment in the Carpathians. Communicating the results to the Carpathian Convention partners, and integrating them into the Carpathian Convention documents

The key messages from the FC and from the Agritourism Congress to the Carpathian Convention have been presented to the Carpathian Convention **Implementation** committee and included into the CC implementation report 2018. Further follow-up focused on Biodiversity, science-policypractice interface, forestry and ESD took place at the meeting of the WG on Biodiveristy. A new format for discussion and cooperation has been tested and appreciated by the Convention focal points and the other participants, and will be continued in the future. Results of the events held in 2019 will be integrated into the CC implementation report of 2019.

# III.4 Assessment of the project by the recipients of advice, and of the collaboration with other partners in the target country

The project received especially strong appreciation at the Forum Carpaticum, by the organizers and the supported participants. This was a highly needed and welcome contribution to the organization and participation at the FC. The appreciation for support was highly recognized at the opening of the FC in several opening statements by the Hungarian organizers and by the Secretariat. The organizers especially appreciated the support for partipants from Ukraine, who often lack the funds to join the FC, as well as other Carpathian Covnention events.

The S4C organizers expressed that the project contributed to a more balanced conference - with respect to the thematic focus, important topics from the social sciences and inter- and transdisciplinary fields have been included into the sessions (such as social innovation in the mountain regions) and via the contribution of the keynote speakers. This was the first time Forum Carpaticum embraced these approaches to such an extent. Support to participants from a Swiss-Ukrainian cooperation project focused on developing and implementing green energy solutions facilitated both NGO representatives and local authorities attending the Forum. Many of the Ukrainian participants were supported by the AAP funds.

The only challenging aspect was the late timing of receiving the funds, which kept a number of participants who needed support waiting to find out whether or not they would be able to take part in the FC – however, all project partners were aware of this challenge in advance, and of the administrative challenges with funding agreements, etc, so this was a very minor issue in comparison to the benefits brought by the funds.

The president director of EURAC as well as the head of Institute of Regional Development, who welcomed and thanked the support of AAP at the opening of the World Agritoruism Congress. Without this contribution, participants from the Carpathian countries could not have attended the Congress, and this would have resulted in cancellation of the Carpathian session. Both these officials reiterated their appreciation in bilateral discussion with the Carpathian Conveniton secretariat.

Moreover, there was highly positive feedback at the Carpathian Convention Implementation Committee meeting from the Carpathian Convention focal points. The lack of interaction between the scientists and the other stakeholders of the Carpathian Convention had been acknowledged before, and all CCIC participants were happy to see a stronger exchange and cooperation, which was facilitated by the project. Both the S4C and the focal points have agreed on the need to continue the stronger cooperation in the future.

Focal points of the convention especially praised the ESD seminar. They were happy that it took place and that the Carpthian Convention secretariat found a way to support this topic - there was a very big gap previously in exchange among the Carpathian Countries on ESD, as well as between ESD and other sectors. All Carpathian Convention focal points received highly positive feedback from the representatives of the Carpathian countries, who took part in the seminar.

The participants of the ESD seminar, including those from Serbia, appreciated highly this event and the opportunity for exchange (it is sometimes a challenge to involve official Serbian participants in Carpathian Convention events, due to the fact that Carpathians occupy a very small part of Serbia, however, ministerial official representatives took part in the ESD seminar).

5 out of 7 Carpthian Convention focal points participated in the exchange between the S4C and WG on Biodiversity, and they were very enthusiastic, potentially considering continuting with

such approach (presentations followed by World Café exchange) in the future, and even considering to integrate this highly interactives format into other Carpathian Convention activities.

The S4C steering committee members highly appreciated the opportunity to have a face-to-face meeting following the Forum Carpaticum, it helped the decisions for the application for Visegrad fund, and discuss a lot of issues for the organization of the next Forum Carpaticum, including introducing more innovative approaches into the FC.

A number of positive experiences and findings have been made while collaborating with the recipients and other partners in the Carpathian region:

- S4C is an established network, and the members of the steering committee are committed
  to the organization of the FC and are open to innovative ideas. They are open to stronger
  science-policy-practice interface, and to the integration of transdisciplinary approaches,
  even thouh they need still support and international collaborations to strengthen these
  aspects.
- During presentations at Forum Carpaticum in several sessions it became clear that there
  exists interdisciplinary research in the Carpathians, and there are researchers using
  participatory methods in their work the only challenge is to facilitate the networking among
  them, and integrate their work into the CC implementation.
- During the ESD seminar representatives from all countries expressed willingness to actively
  contribute to further exchange on ESD, and participants from Poland expressed willingness
  to potentially organize such a seminar in Poland in 2020.

At the same time, certain challenges have been encountered, including the lack of time and capacity on behalf of beneficiaries to be fully self-sufficient with respect to application for funds.

#### III.5 Lessons learned and recommendations

- More efforts should be made to involve and train younger participants in the S4C, who might be eager to learn new approaches and skills, including those related to accessing project funds, and will be able to apply them in the future. The latter has been a challenge, due to the many barriers the younger scientists are facing with respect to the lack of time, having a lot of pressure to publish and sometimes having to work overtime extensively in order both to earn enough and to advance their career.
- Due to the fact that the network is voluntary, not all executive committee members are active, which constitutes a challenge, and the challenges expressed above prevent more young scientists from joining. However, the committee is aware of this and is trying to take measures to involve more young and active members
- We have learned about the strong barriers to interdisciplinary and trans-disciplinary work, which are increasing in some Carpathian countries, due to certain governmental reforms, which favour stronger separation between disciplines.
- The Convention Secretariat provides an important link among experts working in various institutions both within each Carpathian country and among the countries via activities of the Carpathian Convention.

- Part of the challenge regarding access to funds by the Carpathian partners is that many funding agencies often favour better known universites from "western" countries. In order to overcome this barrier, it is important to form more cooperation between Carpathian partners with those from the west. Such cooperations are already growing and were evident during the ESD conference and some have also contributed to the Forum Carpaticum but it is important to facilitate more. In order to do so, we have made contacts with Leuphana University Lüneburg and will try to integrate some of the Leuphana researchers into the work of the Carpathian Convention and activities of the S4C.
- Summer Schools could provide one way of reaching out to the early career scientists, and also to build new networks and partnerships. S4C plans to integrate a summer school into the application for the Visegrad fund.
- Cooperation with the Caucasus region and with the Scientific Network is welcome by the S4C.
  The presentations from Armenia and Georgia made at the Forum (also supported by AAP),
  were highly appreciated and initiated discussions also across the regions. A number of S4C
  colleagues indicated interest to participate in the Caucasus Mountain Forum, which will take
  place in Ankara, Turkey on Oct 30- November 2, 2019.
- Due to the fact that the Carpathian Convention is a working and dynamic process, many additional activities emerged during the project. It was very important that the donors were open to consider an amendment and a project extention the additional activities contributed substantially to the project outcomes! At the same time, we learned that these dynamic emerging outcomes could be envisaged to a certain extent in the application already, which might potentially simplify the process and avoid the need for an amendment.
- Supporting such inter-sectoral dynamic processes as in the case of the given project might
  be challenging due to the fact that a certain flexibility is needed in applying the budget, in
  order to allow for emerging outputs and facilitate more effective outcomes. It would be helpful
  if the programme could allow for more flexibility in this respect. However, in our experience
  the AAP colleagues were highly supportive in helping us adjust the realities of project
  implementation, the administrative challenges, and the emerging needs to the programme
  requirements and limitations.
- We would strongly recommend AAP to count participation in interactive discussion formats, such as world café, among activities considered "active participation" such formats often yield more fruitful results than individual presentations. More innovative formats are currently adopted by conference organizers specifically to encourage more discussion and networking, instead of just individual presentations, which often tend to run overtime and not allow for fruitful discussion and exchange. Moreover, these formats are much more likely to contribute to transdisciplinary and inter-sectoral discussions and outcomes.
