


The purpose


Main results/ question









Are media reports and opinions more in favor of large carnivore conservation than some years ago?



Highest level of threats and pressures in the Carpathians

- Residential and commercial development affecting large carnivores and their habitats (Housing and settlement, Commercial and industrial areas, Tourism and recreation infrastructure)
- Transportation (Roads and Railways)
- Biological resource use and harm (Hunting)
- Natural system modifications (Increased fragmentation affecting the habitats, Isolation from other natural habitat)

Conclusions

- There is hardly any agreement on numbers ...
- Monitoring of LCs is missing in some cases management decisions?!
- No. of damages is increasing
- Action and management plans not developed/ approved across the region

Poaching

Hunters' interest

Livestock depredation
