





Joint Meeting the Working Group on Biodiversity of the Carpathian Convention and the Carpathian Network of Protected Areas Steering Committee

4 March 2009, Vienna, Austria

MEETING REPORT

The Joint Meeting of the Working Group on Biodiversity and the Carpathian Network of Protected Areas was opened at 9:30 on 4th of March 2009, by Mr. Frits Schlingemann (UNEP Regional Office for Europe - Geneva). The meeting requested Mr. Schlingemann to chair the meeting.

1. Opening of the meeting and adoption of the Agenda

Mr. Schlingemann briefly updated the meeting on the conclusions of the Bureau Meeting (2 March 2009) and the 3rd Meeting of the Working Group on Biodiversity(3 March 2009). The main conclusions were presented:

- the Bureau recommended the CNPA Steering Committee to concentrate on undertaking substantial activities rather than on institutional arrangements that are in any case decided by the higher bodies of the Convention and/or at the political level;
- the Note on the CNPA prepared by the Co-Chair of COP2 was briefly presented pointing out the main developments/decisions in place by the Carpathian Convention; he emphasised that currently the CNPA and its Steering Committee are serviced by the Interim Secretariat of the Carpathian Convention (ISCC);
- the Bureau came to the conclusion that all permanent Secretariat issues, including the CNPA Unit/ permanent arrangement, should be discussed at the high level. Slovakia re-iterated its offered to take the lead in facilitating consultations between the three countries Romania, Slovakia, and Ukraine which offered to host the Convention's permanent Secretariat including a CNPA Unit/permanent arrangement.

The Agenda of the Meeting was approved with two modifications; point number 4 became "Future arrangements and activities of the Carpathian Network of Protected Areas"; and under point number 5 – Other matters – Mr. Serhij Gubar (Ministry of Environmental Protection of Ukraine) proposed to discuss about possible (joint) activities to celebrate the Biodiversity Day on 22 May.

2. Update by the interim Secretariat & partners on the latest activities/developments of the CNPA

Mr. Egerer informed the meeting on the ongoing collaboration between the ISCC and the WWF-DCP on CNPA activities. Mr. Baltzer (Director, WWF-DCP) remarked that WWF-DCP is glad to be able to support the meetings and activities of the Network and assured of their continuous and further support as long as funds are available.

Mr. Mircea Verghelet, interim Chair of the CNPA Steering Committee (Romanian National Forest Administration – Protected Areas Service) remarked that the Network was since its beginning helped by various organisations (e.g. ALPARC – Task Force Protected Areas of the Secretariat of the Alpine Convention, WWF, UNEP and CERI) for which the CNPA and its Steering Committee is grateful; in the same time he draw attention to the fact that the CNPA members / the Carpathian countries are the main responsible actors for its development and implementation.

3. Update by the interim chair of the CNPA, Mr. Mircea Verghelet, on the 1st CNPA Conference

Mr. Mircea Verghelet briefly updated the meeting on the 1st Conference of the CNPA held on 23-24 September 2009 in Poiana Brasov – Romania:

- thanked CNPA partners Task Force Protected Areas of the Secretariat of the Alpine Convention, UNEP and WWF-DCP for their support in organising the event;
- he informed the meeting that as requested by the COP2 the participants to the Conference were asked to provide inputs/comments to the Medium-term Strategy and the Work Plan for 2010-2015; the aforementioned documents as well as other organisational details were thoroughly considered by the CNPA Steering Committee that met prior to the Conference on the 22^{nd} of September 2008;
- the Conference was attended by 85 parks' administration members of the CNPA;
- the Conference considered a Declaration and Draft Rules of the CNPA Conference (including a provision that the CNPA Conference would meet every 2 years), developed by the CNPA Steering Committee (22 September 2009).

Ms. Bozena Haczek, present at the Conference in Poiana Brasov, remarked that no official Report was sent to the participants and stressed the necessity of such a document summarizing discussions and conclusions of the Conference; further the Report would be useful not only to the meeting participants, but also to the other decisional bodies of the Convention (WG on Biodiversity, CCIC, COP, etc.). Mr. Mircea Verghelet agreed on the necessity of having a Report after the Conference – the comments/materials were collected by ALPARC and WWF-DCP and will be used to prepare a consistent report.

Further, Mr. Schlingemann remarked – based on the current decisions by the Convention's bodies – that the Protected Areas Conference is not an official body of the CNPA and of the Carpathian Convention (detailed analysis of the CNPA developments to date were presented in the Note on the CNPA – by the Co-Chair of the COP2).

Mr. Gubar remarked that the CNPA is indeed a very important component and mean of implementation of the provisions of the Carpathian Convention, but at this point a complicated structure – separate unit and an official CNPA Conference – would not be needed; instead the number of employees of the ISCC could be increased.

Mr. Niewiadomski emphasized the importance of having available the outcomes (comments and suggestions of the participants) of the CNPA Conference to be included in the Mediumterm Strategy, Work Plan, but also for consideration by the Convention's bodies in the context of shaping the activities and management of the Network, e.g. CCIC, COP, etc.

Furthermore, Mr. Schlingemann suggested to the CNPA Steering Committee members to find an agreement on the status of the CNPA Conference. If an agreement will not be reached among themselves, the question could be forwarded to the bodies at higher level of the Convention.

Ms. Haczek remarked that when considering/deciding on the status of the CNPA Conference within the framework of the Carpathian Convention, financial implications must be taken into consideration. Mr. Verghelet replied that CNPA Conference has no financial implications – as envisaged and clearly laid-down in the Draft Rules of CNPA Conference – for the Convention's budget. Moreover, he stressed the fact that a CNPA without the protected areas in the Carpathians actively involved is pointless.

Mr. Schlingemann suggested to consider the CNPA Conference to become an advisory body composed of experts, which hold the know-how about the issues that the parks/protected areas are facing. Mr. Ivanenko agreed and recalled the recommendation of the Bureau (2 March 2009) to focus on the substance – concrete activities and to leave the decision on the structure/arrangements for the CNPA to the political decision-makers; moreover, he underlined the importance of the CNPA Conference, which brought together for the first time many of the protected areas members of the CNPA, as well as of the discussions, comments or suggestions, e.g. creating working groups on different themes (tourism, park management, etc.) delivered during the event; therefore, he also agreed with the importance and necessity of having the Report of the Conference which should be together with all the other relevant documents (Medium-term Strategy, Work Plan, Rules of the CNPA Conference) circulated for comments and suggestions to all the working groups of the Convention.

On the issue of the CNPA Conference, the Joint Meeting recommended that the CNPA SC should finalize a proposal on the role and place of the protected areas managers gatherings in the Convention process.

The Joint Meeting recommended that the CNPA SC should as soon as possible finalize the agenda for short, medium and long term action by the CNPA for consideration by the CCIC. Furthermore, the CNPA SC should refrain from further discussing institutional issues as the Bureau decided that the secretariat related issues will be discussed and decided at the high level.

4. Future arrangements and activities of the Carpathian Network of Protected Areas

Mr. Verghelet informed the Joint Meeting that some¹ of the CNPA Steering Committee members met informally on 3 March 2009 to discuss several matters on the CNPA activities and future developments; the outcomes² of this informal meeting were circulated to all participants of the Joint Meeting. Moreover, he proposed the following:

- the ToRs of the WG on Biodiversity of the Carpathian Convention to be amended by deleting the reference to the CNPA, its activities and its Steering Committee;
- the new proposed ToRs of the CNPA Steering Committee should be merged with the existing ones of the CNPA.

The Joint Meeting recommended that the CNPA Steering Committee may propose amendments to Biodiversity WG ToRs, for consideration by CCIC. Furthermore, the Steering Committee may propose amendments to ToRs of CNPA for consideration by CCIC (instead of "separate" TORs for CNPA SC).

Further, Mr. Jan Kadlecik briefly updated the participants on the Carpathian Wetland Initiative; the Slovak State Conservancy has submitted a project for approval by the Ramsar Convention Steering Committee – CWI operating as a regional initiative in the framework of the Ramsar Convention during the period 2009-2012. If approved the CWI will benefit of an amount of 15 000 EUR. Moreover, Mr. Kadlecik thanked all the countries/ministries for their letters of support.
