
## **Objective 7**

#### **Project proposals**

 Cooperation with partner organisations (Secretariats of the CC, Ramsar Convention, DANUBEPARKS...), national agencies and ministries in development of the project proposal on identification, conservation, management and restoration of not protected tiny wetlands of conservation importance (Interreg CE programme) as OECMs





Objective 10 Communication, Education, Participation and Awareness



#### Development of a project for training

- Preparation of the Training course on wetlands restoration in cooperation with Ministry of Environment of the Czech Republic (originally planned for October 2020, postponed due to COVID-19 restrictions)
- Held between 18-22 October 2021 (organized by MoE CZ, Czech Ramsar Committee and CWI) in Šumava NP, Slavkovský les PLA, Krušné hory - testing of the format with CZ and SK participants (15); certificates provided
- Planned also for other Carpathian countries

- Consultations within the **WG on the Ramsar Regional Initiatives** (RRIs) - Consultancy for development of draft Operational Guidelines for RRIs; Survey (questionnaire) on RRIs + RRIs Assessment 2016-2019; ToR of the WG on RRIs; draft revised Operational Guidelines for RRIs including new reporting format; draft Report of the RRIs WG for Ramsar SC59; draft resolution on Operational Guidelines and on RRIs; meeting of the WG on RRIs, online meeting of European RRIs (25 March 2022), invitation for the Europe Regional Pre-COP14 Ramsar Meeting session on RRIs (28 April 2022)
- Information on CWI at the meeting of the Czech Ramsar Committee and conference on occasion of the 50 Anniversary of the Ramsar Convention (30 Nov. – 1 Dec. 2021, Mikulov, CZ)
