### 1. Venue

## 3. Getting to Stara Planina by plane

Due to the location of the WG SARD meeting, participants may consider two optional airports, in Belgrade and in Sofia, while booking their fly tickets.

Transfers from the airports will be organized as follows :

- Shuttle bus from the Belgrade Nicola Tesla Airport leaves approx. at 13:00 on 20. April, returns is planned for approx. 8:00 on 22. April. The transfer takes around 4,5 5 hours.
- Shuttle bus from the Sofia Airport leaves at 14:30 on 20. April, returns is scheduled for 8:00 on 22 April. The transfer takes around 2,5 hours.

The above schedules may change slightly according to participants needs. In such a case, participants will be informed in advance.
