Dear Madam/Sir,

Following Rule 5 of the Rules of Procedure for the Conference of the Parties, I have the honour to inform you that, at the invitation of the Government of the Slovak Republic, the Third Meeting of the Conference of the Parties to the Framework Convention on the Protection and Sustainable Development of the Carpathians (COP3) will be held in Bratislava, Slovak Republic from 25 – 27 May 2011. The High Level Segment will be held on 27 May 2011. According to Article 25 of the Protocol on Conservation and Sustainable Use of Biological and Landscape Diversity, COP3 also serves as the meeting of the Parties to the Protocol.

Furthermore, the Protocol on Sustainable Tourism and the Protocol on Sustainable Forest Management are expected to be adopted and opened for signature by the COP at the ministerial segment of the COP3. I kindly ask you to make sure that your delegation is equipped with the necessary Full Powers for signature of the Protocols.
