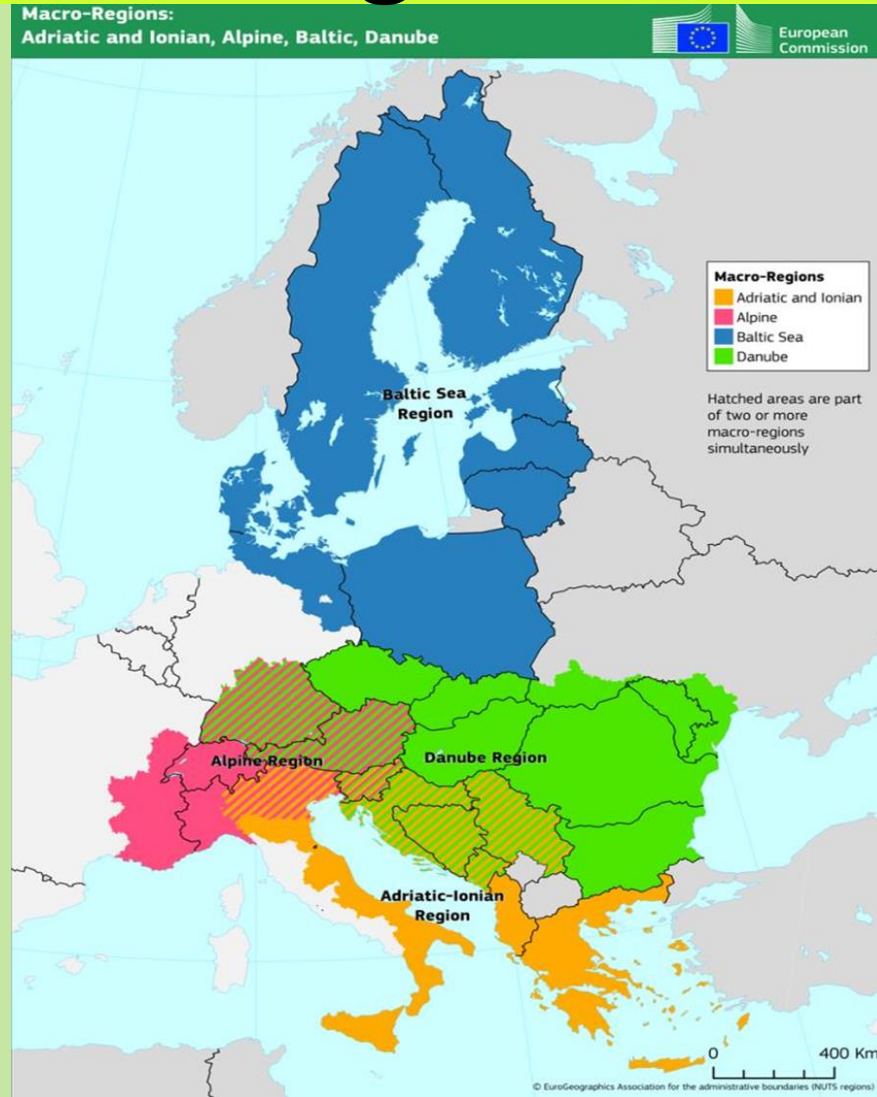

- a bottom-up tool activating entities at various levels of government as well as civil society, science and culture institutions, and economic partners
- tool for shaping European solidarity
- they allow you to focus on selected aspects and territories
- dynamizing development processes at the local and regional level
- undertaking common problems and comprehensive task solving
- an instrument of multilevel governance



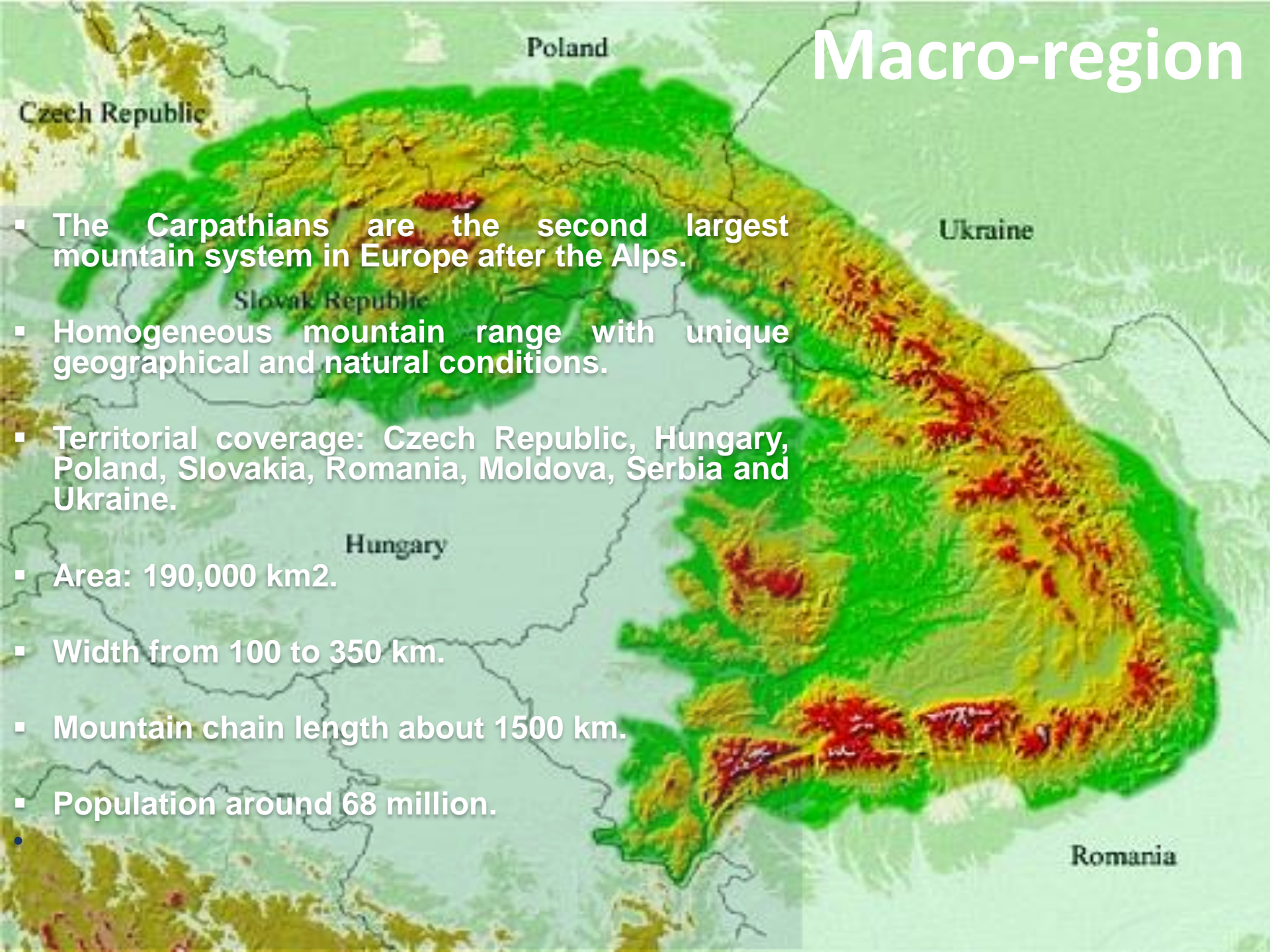
Opinion on Macro-regional Strategy for the Carpathian Region

25 June 2019	Appointment of Władysław Ortyl as rapporteur on the opinion on the macro-regional Strategy for the Carpathian region
24 September 2019	Deadline for submitting the draft opinion to the COTER secretariat before send-out to translation (in case of a 10 standard pages of 1.500 characters document including footnotes, spaces excluded)
10 October 2019 17 October 2019	Deadline to table amendments: - For the members amendments - for the rapporteur (Rapporteur's amendments)
23 October 2019 (Brussels)	Discussion and adoption of the draft opinion in COTER
19 November 2019	Deadline to table amendments: <u>no amendments</u>
4/5 December 2019	Adoption of the draft opinion in COR plenary (adopted on 4th of December)

Macro-region



- The Carpathians are the second largest mountain system in Europe after the Alps.
- Homogeneous mountain range with unique geographical and natural conditions.
- Territorial coverage: Czech Republic, Hungary, Poland, Slovakia, Romania, Moldova, Serbia and Ukraine.
- Area: 190,000 km².
- Width from 100 to 350 km.
- Mountain chain length about 1500 km.
- Population around 68 million.

Recommendations for the Carpathian Strategy

- recognition of the strategy as a mature, well-developed initiative taken at all levels of government
- increasing the possibilities of joint planning and conducting „tailor-made” activities
- response to the need to expand and deepen cooperation between regional and local states and communities in the Carpathian region
- meeting the expectations of residents of countries remaining outside EU structures
- tool for promoting European values the need for European Union accession to the Carpathian Convention as a Party
- calls on the European Commission to support the initiative to create a macro-regional strategy for the Carpathian region as a further macro-regional strategy
- The strategy for the Carpathian area will complement the activities undertaken under the existing Danube Strategy, taking into account the specificity of the Carpathian mountain area
- acknowledging the positive impact of the Carpathian Convention, the importance of its objectives and their convergence with the EU's priorities, calls on the European Commission to take action towards the EU joining this Convention as a party

Carpathian Convention in European Committee of the Regions's opinion

- commends the actions undertaken to implement the 2003 Framework Convention on the Protection and Sustainable Development of the Carpathians (Carpathian Convention) which is a multi-party international agreement on the Carpathian region established on treaty principles of international law. The parties to the convention are obliged to cooperate and pursue comprehensive policy for protection and sustainable development of the Carpathian region, also taking into account objectives and provisions of the Convention in their own sectoral policies (for example, concerning spatial planning, agriculture, forestry, transport and tourism), better coordination of these policies and applying integrated approach principles to management of land resources;
- notes that the Carpathian Convention is a multi-sectoral management mechanism covering the Carpathian region that enables inter-sectoral integration and widespread participation of stakeholders from various levels (national, regional, non-governmental, etc.) The multi-level cooperation standards that have been developed and have resulted in five thematic protocols on the Carpathian Convention can be used as an important part of further cooperation

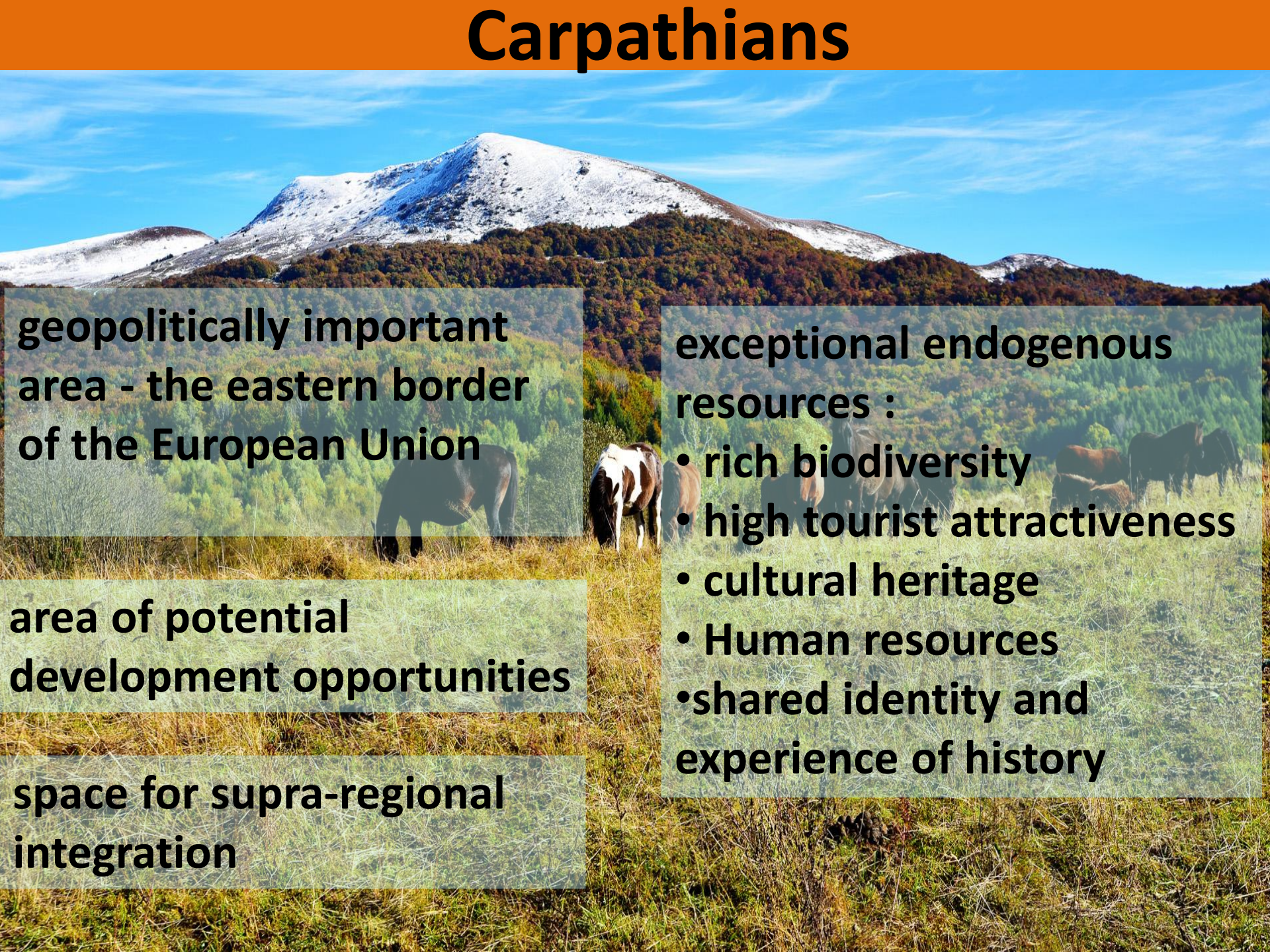

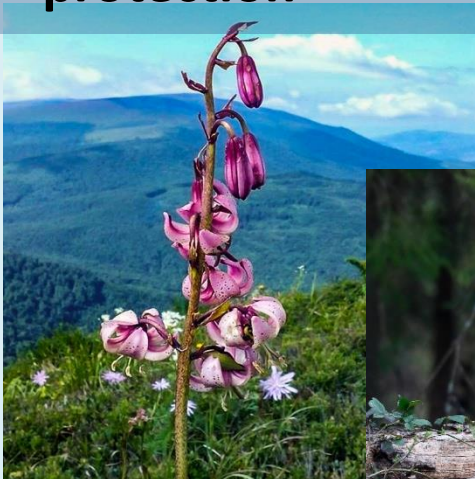
Barriers - challenges

- Distance from European centres.
- Historically conditioned border barriers gradually leveled.
- Potential of centuries-old neighbourhood of the Carpathian regions' societies.
- Low GDP per capita compared to the EU average.
- Ongoing process of economic transformation.
- Weakness of communication connections.
- Deficiencies in infrastructure resources.
- Common climate challenges.
- Untapped potential for economic cooperation.



A wealth of biodiversity

- "Eastern Carpathians" International Biosphere Reserve
- 36 national parks - area 11,000 km²
- 51 landscape parks - 19,000 km²
- 200 other forms of protection
- one of the most important predator refuges
- an important center of endemism
- pan-European ecological corridor
- only 16% of the area outside forms of protection
