





## **MEMORANDUM OF COOPERATION**

#### **BETWEEN:**

The Secretariat of the Carpathian Convention (hereinafter referred to as "the Secretariat")

AND:

The Association of Natural Protected Areas Administrations (hereinafter referred to as "ANPAA")

We welcome the Declaration of the 2nd Conference of the Carpathian Network of Protected Areas, held in Tatranská Javorina on 23 - 26 April 2013 (attached as Annex I);

We note the Terms of References for the Carpathian Network of Protected Areas (CNPA) (attached as Annex II);

We recall the relevant decisions of the Fourth Meeting of the Conference of the Parties to the Carpathian Convention (COP4), Mikulov, Czech Republic, 23-26 September 2014, which expressed its gratitude to the World Wide Fund — Danube-Carpathian Programme (WWF DCP) for its cooperation in the organization of the CNPA Steering Committee meetings and the 2nd Conference of the Carpathian Network of Protected Areas organized back to back to the Mid Term Conference of the "BIOREGIO Carpathians" project, as well as for the development of the activities related to management of protected areas in the Carpathians. COP4 also welcomed the Agreement between the Secretariat and the Alpine Network of Protected Areas (ALPARC) regarding the transfer of the CNPA webpage (www.carpathianparks.org) from ALPARC to the CNPA Unit and encouraged further cooperation on specific topics common to the two network.

## We have reached the following understanding:

## I. AIM

This Memorandum of Cooperation aims at providing a durable basis for the cooperation of nature conservation bodies under the Carpathian Convention and its Protocols.

#### II. FIELDS OF COOPERATION

ANPAA shall assist the Secretariat by serving a CNPA Unit. In the framework of the Carpathian Convention and under the overall coordination of its Secretariat and of the CNPA Steering Committee (SC), ANPAA will carry out the functions of the CNPA Unit as per the Terms of Reference for the Carpathian Network of Protected Areas (CNPA) and as assigned in the CNPA Medium Term Workplan (attached as Annex III) as noted and approved by the COP4 and their updated versions. ANPAA shall follow recommendations made by CNPA SC, Carpathian Convention Implementation Committee (CCIC) and COP.

#### III. REPORTING

Besides day to day interaction and communication, ANPAA will report in writing to the Secretariat and to the CNPA SC once a year after the entry into effectiveness of this MoC and then every year to this date, on the measures and activities undertaken on the basis of this Memorandum of Cooperation and of the Mid Term Workplan of the CNPA. The template of this report will be agreed upon by the CNPA SC.







## IV. USE of LOGOS

ANPAA will use in all relevant documentations the logos of the Carpathian Convention, of CNPA and of ANPAA (respectively in this order). ANPAA will use the respective logos for giving visibility to initiatives of common interest in compliance with the respective regulations on the use of the respective logos. ANPAA shall request all CNPA members to include on their respective web sites the Carpathian Convention and CNPA logos, with a link to the web sites - www.carpathianconvention.org and www.carpathianparks.org.

## V. EFFECTIVENESS

This Memorandum of Cooperation will take effect upon signature from both sides. Its duration is unlimited but each signatory may terminate it by informing the other signatory in writing with a prior delay of 3 months.

## VI. AMENDMENTS

The signatories will, by mutual consent and in writing or the addition of annexes, regularly review and amend this Memorandum of Cooperation on the basis of the experience gained in implementing it.

# **DECLARATION**

# **OF THE**

# 2<sup>ND</sup> CONFERENCE OF THE CARPATHIAN NETWORK OF PROTECTED **AREAS**

Tatranská Javorina, Tatras Region Slovakia 23-26 April 2013





























The representatives of Carpathian protected areas gathered in Tatranská Javorina, Slovakia for the 2nd Carpathian Network of Protected Areas (CNPA) Conference held within the framework of the Framework Convention on the Protection and Sustainable Development of the Carpathians (Carpathian Convention), as a thematic network of cooperation of mountain protected areas in the Carpathians,

Hosted by the Government of Slovakia, organized with the support of the State Nature Conservancy of the Slovak Republic (SNSCR), WWF Danube Carpathian Programme (DCP), UNEP Vienna – Interim Secretariat of the Carpathian Convention (ISCC), CNPA Steering Committee (SC), Alpine Network of Protected Areas (ALPARC), European Academy Bolzano (EURAC), within the SEE BioREGIO Carpathians project and with the financial support of the Visegrad Fund, Carpathian Convention, Ministry of the Environment of Germany, Ministry of the Environment of Slovak Republic, Carpathian Wetlands Initiative, GEF, UNDP Romania, Romanian National Forest Administration,

Pursuant to relevant Decisions of the Third Meeting of the Conference of the Parties to the Carpathian Convention to the Carpathian Convention (COP 3) and in particular the adoption of the Medium-Term Strategy of the CNPA [Decision COP 3/1(5)], adoption of the revised Terms of Reference of the CNPA SC [Decision COP 3/1(6)] and request to the ISCC to service the CNPA SC [Decision COP 3/13(13)],

## Declare as follows:

We turn the attention to the challenges and increasing pressures to the protected areas network which could threaten natural and cultural heritage and ecological connectivity and functionality.

We encourage economic activities in line with the conservation objectives and emphasize the role of protected areas for regional sustainable development.

We emphasize the need for adequate funding for the protected areas network which would allow the proper functioning and the achievement of the management objectives.

We welcome the fruitful cooperation with the international partners (ALPARC, EURAC, Science for the Carpathians Initiative (S4C), UNEP, WWF DCP, and others) and express our wish to continue and to strengthen this cooperation.



























We welcome the results of various projects relevant for the CNPA framework (e.g. MAVA PA4LP, ETC SEE BioREGIO Carpathians, GEF Improving the Financial Sustainability of the Carpathian System of Protected Areas, Alpine-Carpathian Cooperation, Austria-Slovakia cross border Alpine – Carpathian Corridor) and express the willingness to sustain and apply the findings and proposed activities from those projects.

We express our gratitude for the ongoing support of the European Union to our common efforts undertaken in the Carpathians.

We thank the ISCC<sup>1</sup> for the continuous support to the CNPA activities.

We welcome the draft Medium Term CNPA Work Plan 2013 - 2017 presented at the Conference and ask the CNPA SC and ISCC to integrate the outcomes of the Conference to it for submission to COP for approval...

We welcome the establishment of a provisional CNPA Management Unit financed by UNEP Vienna – ISCC through the BioREGIO Carpathians project and sustain the elements of a permanent arrangement for the CNPA.

## ANNEX II

## Terms of Reference for the Carpathian Network of Protected Areas (CNPA)

## Mandate of the CNPA and its Steering Committee (SC)

The First Meeting of the Conference of the Parties (COP1) to the Carpathian Convention (Kyiv, Ukraine, 11-13 December 2006) in its Decision COP1/4 para. 12 decided "to establish the Carpathian Network of Protected Areas, constituting a thematic network of cooperation of mountain protected areas in the Carpathian Region, and to designate one CNPA Focal Point in each Party to start up and encourage cooperation in the management of protected areas within and between the Carpathian countries".

COP1 in its Decision COP1/4 para. 13 decided to establish the CNPA SC composed of the CNPA Focal Point of each country.

The Second Meeting of the Conference of the Parties (COP2) to the Carpathian Convention (Bucharest, Romania, 17-19 June 2008) in its Decision COP 2/1 para. 7 requested "the interim Secretariat in cooperation with the CNPA Steering Committee, with support of the ALPARC and Task Force of Protected Areas of the Alpine Convention Secretariat and in collaboration with the other CNPA partners, to prepare a Work Plan and Medium Term Strategy for CNPA, and invited the Protected Areas Conference to consider and provide inputs to the documents."

## Aim and Tasks of the CNPA

The CNPA constitutes a regional thematic network of cooperation of mountain protected areas in the Carpathians. The CNPA aims to contribute to the protection and sustainable development of the Carpathians, and in particular to accomplishing goals listed in Article 4 of the Carpathian Convention. The CNPA reports to the Carpathian Convention Implementation Committee through the Secretariat.

## The following are the goals of the CNPA

- Promotion of cooperation on protection, restoration of nature and sustainable use of natural and cultural resources of the Carpathians;
- Implementation of decisions and recommendations undertaken by the bodies established under the Carpathian Convention as well as of other applicable relevant international legal instruments;
- Promotion of sustainable livelihoods and sustainable development of the Carpathians;
- Implementation of the relevant provisions of the Protocol on Conservation and Sustainable Use of Biological and Landscape Diversity (Biodiversity Protocol) and of the Sustainable Tourism Protocol and its Strategy.

## The work programme and activities of the CNPA may include:

- making recommendations on expansion of the existing and/or creation of new protected areas;
- capacity building of the member protected areas and of the network;
- communication within the network;
- coordination of common activities and projects undertaken by the network;
- common fundraising from external sources for activities of the network;
- exchange of experience, skills, knowledge and data among network members, including through the CNPA working groups;







- raising ecological awareness and promoting trans-boundary cooperation and sustainable development;
- liaising and cooperating with other bodies established under the Carpathian Convention as well as with
  other relevant international, regional and national organisations under the guidance of the CNPA
  Steering Committee and coordination of the Working Group on the conservation and sustainable use of
  biological and landscape diversity thus building upon the vast experience and knowledge available;
- preparing reports, opinions and recommendations for the Working Group on the conservation and sustainable use of biological and landscape diversity, for further submission to the Conference of the Parties and the relevant bodies established under the Carpathian Convention;
- support the activities of common thematic working groups established under the Carpathian Convention Implementation Committee and common communication actions.

#### **CNPA Structure:**

- CNPA Members
- CNPA SC
- CNPA Unit

## The CNPA SC

The CNPA SC shall aim at supporting the cooperation of the Parties to the Carpathian Convention for the implementation of Articles 4-13 of the Carpathian Convention relevant to the protected areas activities. The main tasks of the CNPA SC are to coordinate activities of the CNPA, to develop strategies and work plans for the CNPA, and to organise the CNPA Conferences.

The CNPA SC coordinates its activities with the other bodies of the Carpathian Convention, including the Working Group on conservation and sustainable use of biological and landscape diversity and with other relevant working groups.

- The CNPA SC is composed of the National Focal Points, nominated by the Parties of the Carpathian Convention. The meetings of the CNPA SC are open for observers;
- Each CNPA National Focal Point will start up and encourage cooperation in the management of
  protected areas within and between the Carpathian countries. This shall be achieved in continuous
  cooperation between the Carpathian protected areas, designated as members of the CNPA, and with
  protected area networks of other regions. The Parties to the Carpathian Convention are invited to assist
  the nomination and participation of the relevant protected areas in CNPA;
- The rules of procedures of the Carpathian Convention apply mutatis mutandis to the CNPA SC;
- The CNPA SC elects a chair for a 2 years period. The Chair of the SC ensures the role of Chair of the CNPA Conference;
- The Chair, or if not possible another SC member, represents the CNPA during the meetings of the other bodies of the Carpathian Convention;
- The CNPA SC will meet at least twice a year and can invite representatives from other bodies of the CC as observers to its meetings.

## Field of activities of the CNPA SC

- Support and coordination of the CNPA activities to accomplish the adopted goals of the CNPA, according to the CNPA ToRs;
- 2. Support and coordination of the activities of the PA administrations related to CNPA, and support for their activities towards implementation of the protocols to the Carpathian Convention;







- 3. Cooperation with the Working Group on the conservation and sustainable use of biological and landscape diversity and with the other working groups of the Carpathian Convention (forestry, agriculture, sustainable tourism, cultural heritage etc);
- 4. Cooperation with the Carpathian Wetlands Initiative (CWI);
- 5. Support for the establishment of new trans-boundary PAs also under the Ramsar Convention and the UNESCO MaB program;
- 6. Cooperation with the CNPA partners, including ALPARC, CERI, UNEP and. WWF-DCP;
- 7. Creation of thematic working groups between the different members of the network, for experience exchange and common projects.

## List of results

- The setup of a webpage containing information on the network and its members;
- The organisation of the CNPA Conference;
- Cooperation with the relevant partners in for the implementation of projects related to the CNPA activities.
