# **Objectives**




- Knowledge/experience among relevant authorities and key stakeholders increased
- Cross-sectoral practices improved relevant to Green Infrastructure for integrated mitigation measures, implementation and monitoring
- International and national governance framework strengthened

# **Main Results**





- Standardized methodology for monitoring structural and functional connectivity
- Local cross-sectoral operational plans for each pilot area
  - Carpathian Countries Integrated Biodiversity Information System **NEW**! <u>https://ccibis.org</u>
  - **Capacity building program** & training events for key players on SEA, EIA, etc.
  - Joint Declaration on ecological connectivity in the Danube-Carpathian region

# **Achievements - examples**





- Increased collaboration between ministries and PPs on the implementation of ecol. corridors
- Plans for Lviv bypass road in Ukraine integrate mitigation measures (green bridges, tunnels)
- Plans for A8 Highway in Romania include more mitigation measures than expected
- SK: **new law for land use planning** includes consideration of ecological corridors
- ISO/TCC 331 Biodiversity contributed to establish ecological connectivity as a topic in the standardization process

### Lessons learnt

Danube Transnational Programme SaveGREEN

- Long-term collaboration is key 3 GREENs
- Never underestimate time needed for stakeholder engagement!
- What is already settled at the national level does not necessarily reach local players
- Need for **established** cross-sectoral collaboration at all levels
- Personal meetings are more effective
- Ecological corridors as public good?
- Legislation unclear need for more awareness raising on the topic
