
The Carpathian Convention

Danube Transnational Programme TRANSGREEN

- A framework Convention for cooperation and multi-sectoral policy coordination
- Adopted on 22nd May 2003
- Entered in force on 4th January 2006
- Ratified by all the seven Carpathian countries(Czech Republic, Hungary, Poland, Romania, Serbia, Slovakia, Ukraine)
- A platform for joint strategies for sustainable development
- A forum for dialogue between all stakeholders involved

Decision Fifth Conference of the Parties (COP5)

Decisions of the Fifth Conference of the Parties, especially **Decision COP5/9 para 2.** recommends:

"the Working Group on Sustainable Transport, Infrastructure, Industry and Energy (hereinafter WG Transport) with support of the TRANSGREEN project, to develop a Strategic Action Plan for fostering the implementation of the Transport Protocol, invites other Working Groups and relevant stakeholders to support the process".





Objectives, Geographical Scope and Definitions

General objectives and principles

"(...) is to enhance and facilitate cooperation of the Parties for the development of sustainable freight and passenger transport and related infrastructure in the **Carpathians** for the benefit of present and future generations with the objective to contribute to the sustainable development of the region while avoiding, minimizing and, where necessary, mitigating and compensating negative environmental and socioeconomic impacts of transport and related infrastructure development.(...) "

Fields of cooperation:

- a) policies of sustainable transport and related infrastructure planning and development, which take into account the specificities of the mountain environment;
- b) development of sustainable multi-modal transport policies, which provide the socio-economic benefits of mobility and access to urban, rural, remote areas and tourist destinations in the Carpathians;
- c) reducing negative impacts on human health and improvement of transportation safety;
- d) avoiding fragmentation of natural and semi-natural habitats caused by all transport modes and related infrastructure, as well as maintenance and improvement of ecological connectivity on the local, national and regional level;




Fields of cooperation:

- e) development and promotion of **environmentally friendly transport models and systems**, in particular, **in environmentally sensitive areas**;
- f) incorporating sustainable transport planning and traffic management in the Carpathians, avoiding overload of transit capacities across the Carpathians where possible;
- g) assuring infrastructural functionality of the transport network;
- h) improvement or maintenance of transport infrastructure in terms of efficiency, safety, security passenger and freight mobility and emissions of greenhouse gases.

Strategic Action Plan for Sustainable Transport in the Carpathians

- Mandate given by Art. 8 and 10 of the Carpathian Convention and COP4 Decision 4/5 and Decision COP5/9
- To be elaborated within the context of the meetings of the Carpathian Convention Working Group on Sustainable Transport and a joint Carpathian Convention Working Group meeting (transport, biodiversity, spatial planning)
- Based on the Guidelines and Recommendations developed within the Project
- Endorsed by the Carpathian countries in order to be adopted at COP6 in 2020 in Poland
