Some facts about biodiversity in Austria

- Among the most species rich countries in middle Europe: ~ 68,000 species, 480 biotop-types, more than 700 endemic species
- 60 % of territory is mountainous, 50% forests,
- On-going biodiversity loss (as in many other countries), but also success-stories
- Ca. 29% protected areas
- Party to the CBD: implementation of GBF
- EU Member State: implementation of EU Green Deal, EU Biodiversity Strategy 2030; FFH etc..

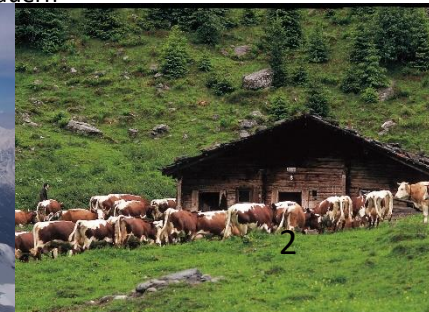

Biodiversity-Strategy Austria 2030+

- Published in December 2022
- Developed through broad participatory process – involving experts, scientists, landowners, NGOs, ministries, provincial governments and the broad public
- Based on EU Biodiversity Strategy 2030 and drafts of GBF

Biodiversity-Strategy Austria 2030+ overriding goals

- Stopp biodiversity loss – bend the curve
- Address drivers of biodiversity loss
- Mainstream biodiversity in sectors
- Transformative Change
- Provide overall framework for biodiversity and relevant financing-programmes and supporting schemes: rural development programm, forest fund, biodiversity fund, etc.

Biodiversity-Strategy Austria 2030+

Ten-Point Work Programm for Biodiversity

- **Targets** for ecosystems (Forests, agricultural lands, mountainous areas, special habitats, incl. urban areas)
- **Targets** for „instruments“ (protected areas, restoration, ecological corridors, etc.)
- **Targets** for all levels of biodiversity
- **Targets** for the relevant sectors
- **SMART** targets!

Ten-Point Work Programm for Biodiversity

Status & Trends

- Minus 30% threatened species and habitats



Protection & Connectivity

- 30% Protected Areas
- 10% strictly protected
- bogs
- 30% of wetlands: 5,000 ha of degraded floodplains are restored
- 1,000 km longitudinal and transverse ecological connectivity of aquatic habitats

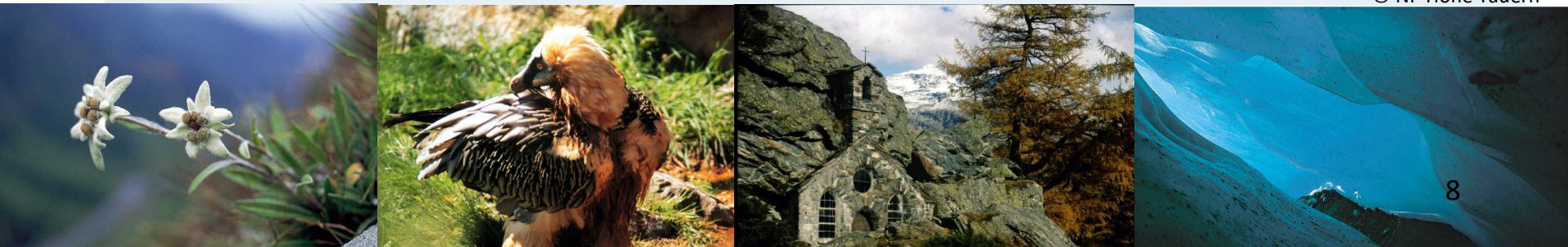


Biodiversity-Strategy Austria 2030+

Mountain pastures and high mountain regions

- Ensure site-adapted **management** of the mountain pastures
- **Protection** of “a technically meaningful proportion” of the **very near-natural and near-natural high mountain areas** in the form of large-scale **wilderness areas and nature reserves** (IUCN 1a, 1b, II), with a focus on contiguous areas larger than 3,000 ha
- **Undeveloped natural areas** in the high mountains are **legally protected** from large-scale development, while the largest possible proportion of the remaining near-natural areas in the high mountains is protected by quiet areas that also permit near-natural alpine farming

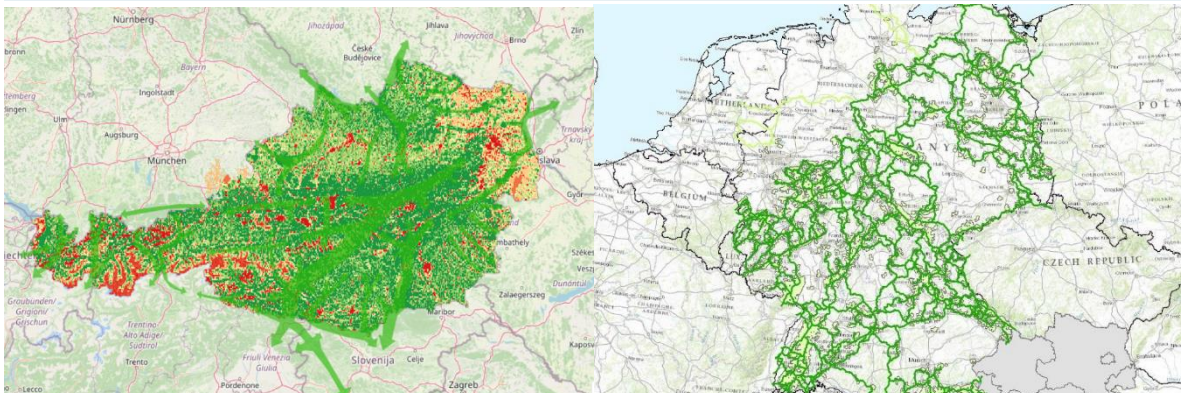

Biodiversity-Strategy Austria 2030+:

Mountain pastures and high mountain regions

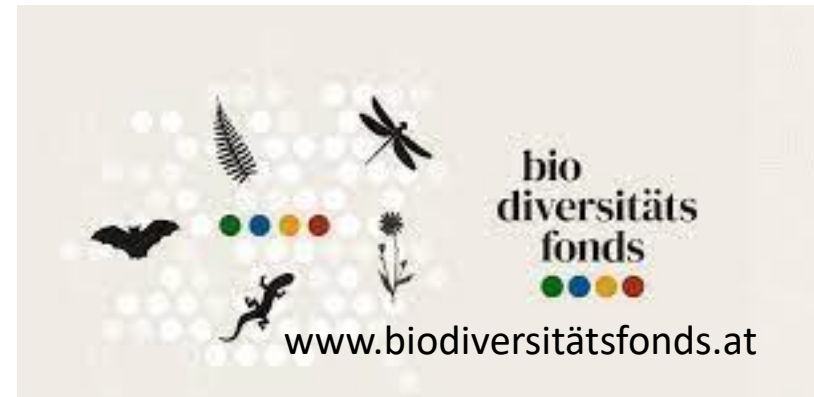
- Strengthening of **green infrastructure** by improving the connectivity of protected areas
- **Restoration of wild animal corridors** or other biotope connection systems – to safeguard connectivity with national and European areas
- **Creation of networks between protected areas** and habitats to improve connectivity and facilitate climate-induced species migration

Biodiversity-Strategy Austria 2030+: Implementation

- Many actors!
- **Biodiversity Fund**: 2021-2026: 80 Mio Euro (50 Mio RRF, 30 Mio national)
- **Dashboard**
- Establishment of new national **Biodiversity-Monitoring-Systems**
- Regular **reports** on status and trends
- Mid-term report in 2026 on implementation of BDS
- **National Biodiversity-Commission**
