# Report of the Seventh Meeting of the Conference of the Parties to the Framework Convention on the Protection and Sustainable Development of the Carpathians<sup>1</sup> (CC COP7)

11 - 13 October 2023 Belgrade, Republic of Serbia

### Opening of the Technical Segment of the CC COP7

The Technical Segment of the Seventh Meeting of the Conference of the Parties to the Carpathian Convention (COP7) was opened by Mr. Harald Egerer, the Head of the UNEP Vienna Office - Secretariat of the Carpathian Convention, who welcomed the participants and invited Mr. Łukasz Rejt, Director of the Department of Nature Conservation of the Minister for Climate and Environment of Poland, in his capacity as the COP6 President, to make opening remarks on behalf of the outgoing Polish Presidency. Furthermore, Mr. Reit invited the representatives of the incoming Serbian Presidency, Ms. Aleksandra Došlić, Head of the Unit for Protected Areas in the Ministry of Environmental Protection of Serbia, and Ms. Jelena Dučić, Senior Advisor in the Ministry of Environmental Protection of Serbia, to welcome the meeting participants.

### SESSION I - ORGANIZATIONAL MATTERS

### 2. Organizational matters

#### 2.1 Election of Officers

#### 2.2 Review of credentials

The Head of the Secretariat of the Carpathian Convention, Mr. Harald Egerer, reported on the submission of the credentials for the Parties' official delegations, allowing for decision-making at the COP7.

# 2.3 Adoption of the agenda

#### 3. Status of ratifications and contributions

The Secretariat provided a detailed overview of the statuses of ratifications of the Protocols to the Carpathian Conventions, including on the Protocol on Biodiversity, the Protocol on Sustainable Forest Management, the Protocol on Sustainable Tourism, the Protocol on Sustainable Transport, and the Protocol on Sustainable Agriculture and Rural Development, as well as the Article 12bis on Climate Change. Serbia described the ongoing process of ratification of the Protocol on Sustainable Agriculture and Rural Development and the Article 12bis on Climate Change.

The Secretariat informed the meeting about the status of contributions to the Carpathian Convention Trust Fund and thanked the Parties for the timely payments.

#### 4. Implementation of the Carpathian Convention: progress and prospects

The Secretariat delivered a comprehensive presentation outlining the progress and main achievements in implementing the Carpathian Convention since the COP6 in 2020, while also reflecting on the celebration of 20 years of the Carpathian Convention. # 5. Formal reading and finalizing the COP7 Decisions

Thanks to the highly efficient negotiation process of the COP7 Decisions between the Parties leading up to the COP7, and the successful finalization of the COP7 Decision text at the COP7 Bureau meeting preceding the Technical Segment, the COP7 Presidency opted against a formal reading of the COP7 Decisions during this stage of the Technical Segment. The finalized draft of the COP7 Decisions was distributed for review prior to the commencement of the Technical Segment, and notably, no reservations were expressed regarding the content.

# 10. Stakeholders' consultations on establishing the Trans-European Nature Network - NaturaConnect

The session facilitated stakeholder consultations on the establishment of the Trans-European Nature Network, aimed at strengthening collaboration within the Carpathian Convention to build a transboundary functional ecological network and integrate ecological corridors across relevant sectors. The consultations were organized as part of the implementation of the NatureConnect project.

#### **SESSION III - OPENING**

#### 12. Opening of the High-Level Segment of the CC COP7

The High-Level Segment (HLS) of the COP7 was opened by the COP7 President, Ms. Sara Pavkov, State Secretary of the Ministry of Environmental Protection of Serbia, who welcomed the COP7 participants, as well as the honorable guests and speakers of the HLS. The COP7 President emphasized the importance if the COP7 as the most significant environmental conference in the region in 2023.

The COP7 President then invited the following speakers to deliver opening remarks.

# 13. Adoption of the Ministerial Declaration COP7

The Secretariat introduced the COP7 Ministerial Declaration, a key document aimed at strengthening the Carpathian Convention's work and advancing the Carpathian Vision 2050, which focuses on living in









harmony with nature in the region. The declaration was presented for adoption at COP7. The full text of the COP7 Ministerial Declaration is available here.

After the Secretariat's presentation, the President invited the Heads of Delegation of the Carpathian Convention to adopt the declaration by acclamation. The Ministerial Declaration was successfully adopted, and the President thanked the Parties, acknowledging it as a significant milestone in the history of the Carpathian Convention.

#### **SESSION IV - PANEL DISCUSSION**

# 14. "20 Years of the Carpathian Convention: Assessing Progress, Inspiring Action, and Shaping the Future in times of triple planetary crisis" - High-Level panel discussion

The panel discussion was attended by the Ministers and Heads of Delegations (HoDs) from the Carpathian Convention Parties. In their interventions, they elaborated on key achievements and milestones accomplished by the Carpathian Convention over the past two decades, which have positively impacted the region's sustainability and resilience. They also discussed how the Carpathian Convention should evolve and adapt over the next 30 years to effectively address the challenges posed by the triple planetary crisis of climate change, biodiversity loss, and pollution. Following the Ministerial representatives, key Observers provided brief interventions, including:

- Mr. Arnold Kreilhuber, Regional Director of UNEP Europe Office, who elaborated on the achievements of the Carpathian Convention over the past 20 years and outlined UNEP's future focus within the Carpathian Convention;
- Ms. Musonda Mumba, Secretary General of the Ramsar Wetland Convention Secretariat, who highlighted the longstanding collaboration between the Ramsar Convention and the Carpathian Convention, discussing key accomplishments of this partnership and sharing her vision for elevating cooperation in the coming years;
- Ms. Alenka Smerkolj, Secretary General of the Alpine Convention, who emphasized the strategic
  partnership between the Alpine and the Carpathian Conventions, given their specific status as the
  only two mountain conventions in the world. She also shared her vision for joint efforts to
  strengthen the role of mountains and mountain biodiversity in European and global environmental
  agendas;











- Mr. Arno von Wimpffen, Deputy Director General of the International Council for Game and Wildlife Conservation, who discussed ongoing cooperation with the Carpathian Convention and identified priorities for future collaboration.
- Mr. Andreas Beckmann, Regional CEO of WWF CEE, who elaborated on how the Carpathian Convention can actively inspire and engage stakeholders to take meaningful actions that contribute to shaping a resilient and ecologically sustainable future for the Carpathian region.
- Ms. Rosalaura Romeo, Coordinator of the Mountain Partnership Secretariat FAO, who provided insights on potential areas for strengthening cooperation between FAO and the Carpathian Convention in the future.
- Mr. Paolo Angelini, Head of Delegation Permanent Committee of the Alpine Convention and Chair of the Alpine Biodiversity Board, representing Italy as a longstanding supporter of the Carpathian Convention, reflected on the achievements of the Carpathian Convention over the past 20 years and discussed potential areas for future cooperation with Italy.

#### **SESSION V - SUBSTANTIVE INPUTS**

#### 15. Addressing the triple planetary crisis in the Carpathians

Invited speakers provided substantive contributions to the COP7, focusing on the triple planetary crisis in the Carpathians and the initiatives, instruments, and projects being developed within the framework of the Carpathian Convention to address these challenges. The invited speakers included:

 Ms. Joanna Zawiejska, Chair of the Science for the Carpathians (S4C), who highlighted the critical scientific contributions made by the S4C network, which has supported the Convention's work since 2008.

The President acknowledged the essential role of science in the decision-making process, emphasizing the importance of the S4C Network, which connects scientists across disciplines and national borders, promotes research focused on the specific needs of the Carpathian region, and fosters dialogue between research, policy, and practice.

- Ms. Jamal Annagylyjova, CBD Secretariat, who presented the Kunming Montreal Global Biodiversity Framework (GBF) and its role in driving global, European and regional implementation through stakeholders' actions.

## 16. Strengthening partnerships in the framework of the Carpathian Convention

The President stressed the importance of enhancing and building new partnerships that allow for establishing synergies to tackle the challenges facing the region and beyond. The Carpathian Convention already has a broad portfolio of strategic partnerships; however, the COP7 provided an opportunity to reinforce existing partnerships and welcome new ones. The following memoranda of cooperation were signed:

- Renewing the Memorandum of Cooperation between the CBD, Alpine and Carpathian Conventions

After a short presentation introducing the Memorandum of Cooperation (MoC) and its background, the representatives of the Conventions—Ms. Jamal Annagylyjova, CBD Secretariat, Ms. Alenka Smerkolj, Alpine Convention Permanent Secretariat, and Mr. Harald Egerer, Carpathian Convention Secretariat—provided short interventions on behalf of their respective Secretariats on the relevance of the cooperation within the MoC, which was followed by the exchange of the signed MoC.

- Signing of the Memorandum of Cooperation between Carpathian Convention Secretariat and UNIDO

Mr. Harald Egerer, on behalf of the Carpathian Convention Secretariat, and Mr. Josef-Christoph Karl Pelikan, Chief of Cabinet and Special Representative for Eastern Europe and Central Asia of UNIDO, on behalf of UNIDO, delivered short interventions on the importance of the newly established cooperation for strengthening the role of sustainable industrial development in the Carpathian region.

- Signing of the Memorandum of Cooperation between Carpathian Convention Secretariat and EUROMONTANA

After a short presentation of EUROMONTANA's work and their recent and planned activities that are relevant for the Carpathian region, Mr. Radu-Adrian Rey, Vice President of EUROMONTANA, together with Mr. Harald Egerer, on behalf of the Carpathian Convention Secretariat, made brief interventions on the relevance of strengthening cooperation and proceeded with signing the MoC.

- Signing of the Memorandum of Cooperation between the Carpathian Convention and the Global International Year of Rangelands and Pastoralists 2026 Coalition

Mr. Harald Egerer, Carpathian Convention Secretariat, and Francesca Pasetti, Regional International Year of Rangelands and Pastoralists Support Group- Europe, briefly spoke about the new cooperation framework being developed under the Convention and its importance for the region and proceeded with signing the MoC.











# - Announcing the new Transboundary Ramsar site in the Carpathians

The COP7 participants were informed that the Letter of Designation of Transboundary Ramsar site Iron Gates Natural Park – Djerdap between Romania and the Republic of Serbia was signed during the COP7 during the bilateral meeting of Serbian and Romanian ministers.

This designation, in line with Article 5 of the Ramsar Convention regarding governance of wetlands extending over the territories of more than one Contracting Party, will further support the implementation of several multilateral environmental agreements: the Ramsar Convention, Convention on Migratory Species of Wild Animals, Carpathian Convention and the Carpathian Wetland Initiative, ultimately contributing to the implementation of the GBF. The designation of this transboundary site will allow for improved management and conservation of wildlife and their habitats, with the aim of safeguarding biological diversity, as well as facilitating the development of joint research programs and the exchange of knowledge and information.

#### SESSION VI - ADOPTION OF THE COP7 DECISIONS

### 17. Brief report on the COP7 Technical Segment by the Rapporteur and adoption of the COP7 Decisions

The COP7 Rapporteur, Ms. Zlatica Csontos Šimoňakova, National Focal Point, Ministry of Environment of the Slovak Republic, delivered a brief report of the COP7 Technical Segment. The Report is available on the COP7 website.

Following the report, the President proceeded with the adoption of the COP7 Decisions. The President reminded the Parties that they had access to the complete set of critical decisions and accompanying documents, which would be adopted as a package. Emphasizing their importance for the sustainable future of the Carpathian region, the President reiterated that the Serbian Presidency would fully support their implementation, including through its Presidency priorities. The <a href="COP7">COP7</a> Decisions were adopted by acclamation, after which the President officially announced their adoption.

In conclusion, the President expressed gratitude to the Parties for their excellent cooperation and congratulated them on the successful adoption of the COP7 Decisions.

#### 18. Closure of the COP7

Following brief closing remarks, the President officially declared the closure of COP7.

On 13 October 2023, the host organized an excursion to Djerdap National Park for COP7 participants.
